

# ACKNOWLEDGEMENT OF RISK AND WAIVER STUDENTS AND PARENTS

Welcome to the North Orange County Chinese School (NOCCS)! We want you and everyone to have a memorable and safe experience.

The NOCCS's environment, facilities, and activities are unique and different from your usual surroundings and activities. There are many inherent risks, dangers, hazards and everyone must exercise caution at all times in order to minimize the risk of damage, injury, and death.

Examples of these risks, dangers, and hazards include, without limitation: (a) walking and standing surfaces that may be wet, slippery, moving, irregular, unstable, and rough; (b) open areas such as parking lot where someone could fall; (c) low or irregular lighting, or no lighting at all; (d) objects and equipment that could fall on someone; (e) low ceilings, air condition units and other apparatus that are close proximity to class rooms ; (f) ropes, chains, and other items that could strike or entangle someone; (g) extreme and variable physical weather, including darkness, sun glare, storms, and hot and cold temperatures; (h) buildings, ladders, retaining walls, fences, gates, ramps and stairs which someone could fall; (i) possible encounters with wildlife and plants; (j) unavailability of medical attention and treatment; and (k) injury caused by any item, merchandise, or food purchased from NOCCS

If you attend NOCCS and its activities, then you must exercise caution at all times to protect yourself and others from these risks, dangers, and hazards. If children or other persons under your care attend any NOCCS activities, then discuss these risks, dangers, and hazards with them as they too must exercise caution at all times.

If you attend North Orange County Chinese School and any of it's events or events coordinated by the North Orange County Chinese Culture Association (NOCCCA), then by signing this document, or by your attendance, or by your child(ren)'s attendance, you and such other persons shall be deemed to have and understood this document and to have irrevocably waived any and all claims against NOCCS and NOCCCA, NOCCCA's affiliates, Villa Park High School, Orange Unified School District and their directors, officers, employees, contractors, volunteers, agents, and insurers (collectively "RELEASEES") for damage, injury, accident, illness, or death occurring during or by reason of such activities.

I further hereby AGREE TO INDEMNIFY AND HOLD RELEASEES HARMLESS and RELEASE and each of them, from any loss, liability, damage or costs, including court costs and attorneys fees, that may incur due to you or your child(ren)'s attendance of and participating in NOCCS and/or NOCCCA's events.
